The following types of work are unacceptable when using BARC funds:

1. Expenses related to Winter maintenance operations
2. Mn/DOT's labor costs
3. Routine patching
4. Expenses related to routine vegetation control
5. Culvert & edge drain cleanout
6. Drainage assessments
7. Spot patching
8. Any work to Mn/DOT facilities, grounds, or owned properties
9. Planning studies & corridor studies
10. Repair due to hits of guardrail, fence, attenuators, signs, and signposts
11. Service fees for RWIS, ITS, TOCCs
12. Inspection activities
13. Construction related items like laptops, cell phones, vehicles.
14. Any routine maintenance agreement
