

**Summary of Local HSIP Solicitation II
ATP 3, ATP4, ATP 6 & ATP 8
State Fiscal Years (SFY) 2012R, 2013 & 2014**

Project Selection:

- A five member selection team with representation from the State Aid Division (SALT), the Office of Traffic, Safety, and Operations (OTSO) and the Federal Highway Administration (FHWA) ranked each application.
- All project are required to meet the intent of the Strategic Highway Safety Plan (SHSP)
- The applications were first grouped by Area Transportation Partnership (ATP), then into two (2) categories, proactive and reactive strategies.
- Projects were selected from each ATP based on:

PROACTIVE PROJECTS:

- Developed through the County Roadway Safety Plan (CRSP) process
OR
- Substantial compliance with projects listed CRSP
 1. All modified projects must have provided sound documentation for selection to be considered.

REACTIVE PROJECTS:

- Benefit/Cost Analysis greater than 1.
- A list of funded proposals by county and project type is provided in Exhibit A.
- The Central Safety Fund monies are fully funding the County Highway Safety Plans; therefore, no roadway projects were selected for this funding during this solicitation. Additional information about the County Highway Safety Plans is available at the following link:
